The National Institutes of Health recently estimated our polluted environment accounts for 50% of cancer risk. There are more than 3,800 chemicals in daily use, many of which make their way into our drinking water. Less than half of these have been tested for toxic effects in humans, and fewer than 10% have been tested for toxicity in children.

According to National Geographic, from 1950 through 1985 “We disposed of six billion tons of toxic throwaways in or on the land, steadily increasing our exposure to chemicals (from contaminated tap water) that can cause cancer, birth defects, miscarriages, nerve disorders, blood disease, and damage to the liver, kidneys or genes.” Each year, the problem only grows worse.

And, you’re not likely to be aware of these chemicals in your drinking water because practically all toxic contaminants are tasteless, odorless and invisible.

How can you ensure your family's drinking water is healthy?

First and most important, stop drinking unpurified tap water.

Next, invest in a high-quality water purification system that makes your home drinking water 100% safe at the point of use. If you are currently using an inexpensive, low quality purification system, consider investing in a better one. Most in-home water purification systems are only partially effective in removing dangerous contaminants, and many remove only a fraction of the impurities and toxins.

To be considered totally pure, drinking water should be 100% free of organic pollutants and greater than 99% free of total dissolved solids (TDS). Contaminants commonly remaining in tap water or water that has been filtered by ineffective treatment systems include:

- » Viruses
- » Heavy Metals
- » Asbestos
- » Arsenic
- » Chemical Solvents
- » Pesticides
- » Herbicides

How it works:

PWS™ BEV systems use a unique, multi-phase purification process combining activated carbon, reverse osmosis, and deionization. Working together, these technologies completely eliminate all impurities including chlorine, fluoride, dissolved salts, heavy metals, nitrates, pesticides, and waterborne bacteria, cyst, and virus.

What is 'BEV'?

The Bio-Electronic Vincent, or BEV, is used to measure water's biological compatibility with the human body as defined by the pioneering research of Prof. L.C. Vincent of France. BEV standards demand a much higher degree of purity than local, state, or federal guidelines.
